



PLC Armidale has made available their three dormitory houses: Todd McBean – two floors, Austin and Hilton single floor, a total of 96 beds, for competitors in the 2024 AOC carnival.

The Dormitories will not be available until 15:30 on 27th September and must be vacated no later than 10.00 Monday 7th October

The rooms will be allocated by PLC under the principle of filling one house first before opening the next one. Note that rooms will be mixed.

The dorm blocks will not be locked nor the bed rooms. It is the participants' own responsibility to keep their personal item safe.

Conditions: Please read the terms and conditions below. Importantly any damage to the facility will be charged to Orienteering Australia, which will then be passed onto the person responsible.

Cost: \$60 per bed per night.

The kitchenette has an oven, 4 hotplate cook top, microwave, standard sized refrigerator, sink.

There is very limited crockery, cutlery, pots and pans as they are used by the boarders for snacking rather than meals.

Bed Rooms

Each room contains up to 6 cubicles each containing a single bed and desk. Each bed will be provided with 2 single sheets plus 1 mattress protector BYO Pillow and any necessary bedding.

Other Special Conditions

- a. Parking on the grounds is only allowable in the general parking areas off Crest Road.
- b. Visiting vehicles are not allowed to park or be driven on any grassed areas and that all traffic must obey the road signs and speed limit.
- c. The users will be responsible for any damage occurring from use of any rooms, facilities or equipment.
- d. The users shall ensure that the premises remain in the same condition after use as before use. On each occasion.

GENERAL The users agree:

- i. To operate only those activities agreed by the Licenser;
- ii. To comply with all regulatory requirements;
- iii. To provide a safe environment to guests, patrons and employees
- iv. To keep the premises reasonably clean;
- v. To notify the Licenser as soon as practicable of any damage to the premises;
- vi. To ensure that nothing is done that may prejudice any insurance policy held by the Licenser;
- vii. Not to promote, exhibit or display in the premises any material or decorations which would be in conflict with the principles of the Licenser;
- viii. Not to hold or permit to be held any sale by auction on the premises;
- ix. Not to conduct or allow any gambling on the premises;
- x. Not to use or cause the premises to be used for any illegal purpose;
- xi. Not to cause or permit a nuisance or interference with the reasonable peace, comfort or privacy of neighbours;
- xii. Not to intentionally or negligently cause or permit any damage to the premises;
- xiii. Not to attach or remove any fixture or renovate, alter or add to the premises without the Licenser's written permission;
- xiv. Not to alter, remove or add any lock or other security device unless the Licenser agrees and is provided with a copy of the key or opening device or necessary information to open any lock;
- xv. Not to assign the whole or part of the Licenser's interest under this agreement or sub-let the premises;
- xvi. Obey rules and regulations as the Licenser may from time to time make and communicate to the Licensee;
- xvii. To indemnify and hold the Licenser and The Presbyterian Church (New South Wales) Property Trust harmless unconditionally against any loss, injury or damage arising from this agreement or the Licensee's use of the premises:
- xviii. When the agreement ends to leave the premises as nearly as possible in the same condition, other than fair wear and tear;
